### **REPORT OF MEDICAL HISTORY**

All entering Boston University students have pre-matriculation health requirements that must be completed prior to your first term at Boston University. If you do not submit these forms prior to the first day of classes, you must submit them within the first two weeks of the semester. IMPORTANT! Failure to complete the required health requirements will result in a registration hold on your Student Account. **An Immunization and Physical Form is required of all new students. ### FINANCIAL AID -- STIPEND PAYMENTS - PhD Students

Information for students receiving Boston University financial aid will be provided at registration. Problems or questions concerning financial aid should be directed to the Graduate School Financial Aid Office, Suite 112, 705 Commonwealth Avenue (Tel. 617-353-2696 or email at <u>grsaid@bu.edu</u>)

Students awarded Graduate Stipends, Teaching Fellowships or Research Assistantships obtain their monthly stipend checks from their academic department office. These checks are normally available on the last Friday of each month.

By federal law, all employers must verify the employment eligibility of their new employees, including student employees. All entering graduate students who have been awarded a Teaching Fellowship, Research Assistantship or Graduate Stipend, or who plan to seek employment on campus, are required to provide documentation for payroll purposes. You will need to present the appropriate documents considered acceptable by the U.S. Congress for employment in the U.S. This documentation must be presented to the administrative assistant in your academic department. Documents must be verified within the first three working days of employment. You will be asked to complete an Employment Eligibility Form (Form I-9). If you are not a U.S. citizen or permanent resident of the U.S., please present the documentation, in person, to the university's International Students and Scholars Office.

STUDENT LOANS For students who wish to apply for federal student loans, you will need to complete a FAFSA using the following website: <u>http://www.fafsa.ed.gov/</u>. Boston University's title IV code is 002130. In addition to this form you will also need to complete a Loan Request Form which is available by contacting the Graduate School Financial Aid Office at 705 Commonwealth Avenue, Room 112, Boston, MA 02215 (Tel. 617-353-2696 or email <u>grsaid@bu.edu</u> Federal loan decisions are usually made in mid July for new graduate students.

For students who wish to borrow private loans, it is advised that you begin the loan process at least 6 to 8 weeks before the first day of classes. Following is a list of websites for various private loan options (please choose only one):
