Camp Terrier Code of Conduct

Our staff at Camp Terrier strives to ensure that every camper has an enjoyable and safe experience at camp. To do so, we expect campers to always act in an appropriate and respectful manner. Campers are responsible for following these guidelines.

The categories of behavior that Camp Terrier staff have been trained to identify and address are called the 3 D's.

Disrespectful – Behaving in a way that is deliberately uncivil, rude, or inconsiderate towards peers or counselors.

Disruptive – Behaving in a way that inhibits the ability of the group to work together and enjoy camp.

Dangerous – Engaging in activities that put the physical and emotional well-being of peers and counselors at risk.

We see each of these categories of behaviors as problematic to the overall success of camp, and behaviors that Camp. Terrier staff identify as falling into these categories may result in the following disciplinary steps:

- 1. A conversation with a counselor about their behavior, and how they can make better choices.
- 2. A conversation with a camp administrator (Director or Assistant Director) about their behavior.
- 3. A conversation between the camper, parent/guardian, and Camp Director to discuss camper's behavior, what steps have already been taken, and what steps may follow.
- 4. A conversation between the camper, parent/guardian, Camp Director, and Camp Executive Director about whether Camp Terrier is the right program for the camper, including a dismissal from Camp Terrier

**Please also note that more extreme or severe violations of Camp Terrier rules and expectations may result in an acceleration of the disciplinary process. **

It is the responsibility of the parent/guardian to review and discuss the Camp Terrier Code of Conduct with their child. I have reviewed the Camp Terrier Code of Conduct with my child. We understand that failure to meet expected and appropriate behavior may result in disciplinary action and/or removal from the camp program.

Paperwork Checklist

Camper Checklist – These Items SHOULD come to camp with your camper each day.

- Medication (must be accompanied by paperwork from the child's physician and Authorization to Administer medication)
- A healthy lunch (glass bottles are not allowed)
- Two snacks (one for the morning & one for the afternoon)
- Refillable Water bottle
- Socks & Closed-Toe Shoes (flip-flops are not allowed)
- Appropriate athletic clothing
- One-piece bathing suit (Tankinis are not permitted)
- Towel (and a plastic bag to store the wet suit/towel)
- Goggles & Swim cap Sunscreen & Hat (for sun protection when outdoors)
- Shoes with backs for sailing (should be able to get wet)

***As a reminder, please be sure that all your child's belongings are clearly labeled.

Please DO NOT send your child to camp with money, as they are not allowed to buy food or drinks from vending

machines. Similarly, please **DO NOT** allow your child to bring any valuables to camp.
