## International Relations and Internal Debates in the Global 1970s

In public memory and among professional historians the 1960s have gained more attention than the 1970s. On the one hand this is understandable, since many political and social changes took off during the 1960s. On the other hand this focus on the 1960s is unfortunate, because it was in the 1970s that these changes first became major shifts that impacted upon Western societies as a whole.

A research network centering around the universities of Münster, Utrecht, Boston and Leiden analyses the developments in the 1970s in a transnational comparison. In 2011 the network held its first conference in Boston about "The Radical Decade in Global Perspective". Researchers from Germany, the Netherlands, the US, France, the UK, Italy, Poland and Switzerland will now focus on the origins of Détente, the internal debates in the 1970s about East-West relations, the birth of protest movements, the emergence of human rights and Détente's other consequences on national politics.
