- Lead FBI's High Performance & Sustainable Buildings Program and coordinate with project teams to meet federal sustainable design & construction requirements—as well as LEED certification—in FBI construction and renovations Bureau-wide

- Provide strategic direction for FBI's sustainable acquisitions program, coordinating with
  procurement officials to improve compliance with federal sustainable acquisitions guidelines and
  advising on contract language that gives preference to environmentally preferable products and
  services
- Lead FBI's waste diversion program, working with FBI facilities to reduce waste and improve
  municipal solid waste diversion practices; coordinating an annual data call to the Department of
  Justice; managing FBI's Recycling Proceeds Recoupment program; conducting outreach and
  education; and exploring organics composting opportunities
- Coordinate with Department of Justice, Department of Energy, and FBI functions on climate resilience strategies, planning, and requirements
