#### **CURRENT BOOK PROJECTS:**

*Creative Rivalry: Charles Dickens and Harriet Beecher Stowe*. Examines, in transatlantic cultural context, the rivalry and mutual influence of Stowe on Dickens and Dickens on Stowe, in the context of the development of the Victorian multiplot, multi-genre, social novel.

Marriage and Money in American Fiction 1798-1925. Examines how Americans' understanding of marriage and its economic aspects shapes, and has been shaped by, the American novel. Tracing the legal, economic, and historical shifts in marriage from the Revolutionary period to the 1920s, the book asks what the implications for fiction are if we think of marriage as a contract, with its aspects of consent, bargain, and commerce? Authors include Foster, Phelps, Wharton, James, Fitzgerald, Loos.
